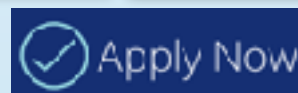

What You Need To Know: New Online & Mobile Banking Systems Coming June 1, 2021

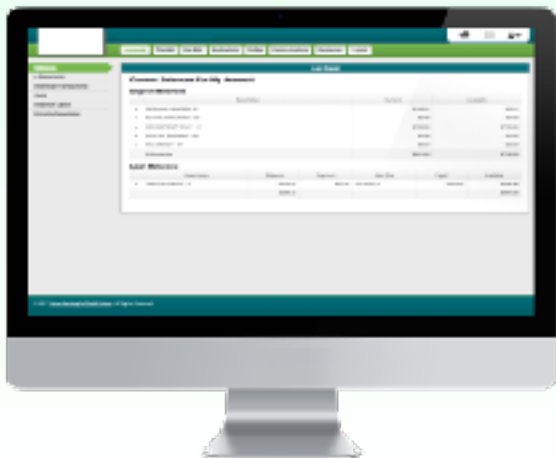
